1. Resolution to Approve Real Estate Counsel Services for Fiscal Year 2019

WHEREAS, the College needs to contract for real estate counsel services; and,

WHEREAS, the term of the agreement is from November 1, 2018 through October 31, 2019; and,

WHEREAS, John Curley, LLC is the proposed vendor to provide these real estate counsel services; and,

WHEREAS, the proposed hourly rate is \$150 and consistent with the prior year; and,

WHEREAS, the cost of these services will be funded from the operating budget; and,

WHEREAS, the Administration and Finance Committee recommend this award;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Hudson County Community College hereby awards a contract for real estate legal counsel services to John Curly, LLC for the period of November 1, 2018 through October 31, 2019, by the terms of the proposal submitted by the law firm;

2. Resolution to Approve General Legal Counsel Services for Fiscal Year 2019

WHEREAS, the term of the agreement is from November 1, 2018 through October 31, 2019; and,

WHEREAS, Scarinci Hollenbeck, LLC is the proposed vendor to provide these general legal counsel services; and,

WHEREAS, the proposed hourly rate is \$185 and is an increase of 5.71% from the prior year; and,

WHEREAS, the cost of these services will be funded from the operating budget; and,

WHEREAS, the Administration and Finance Committee recommend this award;
