1. Award of General Counsel Legal Services for 2016

WHEREAS, the Hudson County Community College has determined to contract for a general counsel legal services for the College; and

WHEREAS, the College has used a business certification process to award this contract for general counsel legal services for the; and

WHEREAS, the College has reviewed and approved of the proposal from Scarinci Hollenbeck to provide general counsel legal services for the Hudson County Community College; and

WHEREAS, Scarinci Hollenbeck executed and submitted the business certification that allows the College to award this contract pursuant to N.J.S.A.19:44A-20.5; and the Administration and Finance Committee recommends this contract; and

WHEREAS, the cost of these services will be funded from operating budget; and

NOW THEREFORE, BE IT RESOLVED the Board of Trustees does hereby authorize the College to enter into an agreement with Scarinci Hollenbeck to provide general counsel legal services for Hudson County Community College, in accordance with the proposal for these services.
