Awards, Recognitions and Special Reports

President Gabert reported on the following:

- October 10th --- Board of Trustees Meeting in anticipation of Middle States Commissioner's visit – President Gabert requested the relocation of meeting from North Hudson Campus to Journal Square Campus – Mary T. Norton Room, 70 Sip Avenue.

- Enrollments are up 8-10%.
- President Gabert said that August 11th will mark his 25th year anniversary as
 President of HCCC. He thanked the Board of Trustees for their continuous support
 and leadership throughout the years.

The trustees approved the minutes of the Regular Meeting of June 13, 2017.

- 3. The purchase of New Masterclave for Microbiology and Equipment for the STEM Building was awarded to VWR (NJ State Contract Number 75846) at a cost not to exceed \$80,752.58.
- 4. The Purchase of Internet Services for FY18 was awarded to NJEdge.net of Newark, New Jersey, at a cost not to exceed \$146,373.00.
- 5. The Renewal of College's Campus-Wide Software License Agreement for FY18 was awarded to GHA Technologies, Inc. of Phoenix, Arizona, at a cost not to exceed \$59,441.51.

- 8. Award of Consultant Services for Title V Picking up the Pace Grant was awarded to Elizabeth Nesius, Director of English, through December 20, 2017 at rate of \$37.55 per hour, at a cost not to exceed \$5,000.00.
- 9. Award of Consultant Services to Review New Program in Medical Sciences Pre–professional was awarded to Dr. Krista M. Wolfe, engagement to be completed by October 1, 2017, at a cost not to exceed \$2,500.00.
- 10. Award for Title IX and Harassment Training was awarded to Safe Colleges for five years, beginning September 1, 2017 until August 31, 2022, at a cost not to exceed \$6,400.00.
- 11. The Updated Hudson County Community College Non-Discrimination/Anti-Harassment Policy was approved.
