Paul Silverman: Shaping the Skyline, and the Community

The skyline of Jersey City is in a constant state of evolution, but one enduring presence in its growth is Paul Silverman. As the co-founder with his brother, Eric, of the prominent, award-winning real estate development firm SILVERMAN, Paul has not only played a pivotal role in revitalizing Jersey City's downtown and waterfront districts-he has also been a steadfast supporter of the community, notably through his long-standing relationship with Hudson County Community College additional (HCCC) and charitable initiatives supporting public education and other worthy causes.

Under Paul and Eric's leadership, SILVERMAN has developed over 1,000 new residences and hundreds of thousands of square feet of commercial and industrial space. These efforts have breathed new life into the city and its economy, creating thousands of jobs and new residences, and contributing to the vibrant atmosphere that defines modern Jersey City.

Paul's commitment to community development extends far beyond bricks and mortar. As a longtime and devoted advocate

for education, he has been a consistent supporter of the HCCC Foundation, helping countless students pursue their academic and career goals. His passion for giving back is rooted in values instilled by his parents, who emphasized the importance of compassion and supporting others.

A strong believer in the transformative power of public education, Paul refers to it as "the most important thing for our society" and "the key to everything." He explains, "I was fortunate to receive a good education and to be in a position to contribute to society. I want others to have that same opportunity."

Why is Paul a strong supporter of HCCC specifically? He describes it as "a school with people who truly value education and the opportunity to pursue their goals."

While Paul believes that helping others and giving back is reward enough in and of itself, throughout the years, Paul has been moved by the gratitude of those he has supported and seeing the impact of his support. One particularly profound example involves a student from Kearny, a community he

feels a strong connection to as the site of his late father's warehouse. After funding a scholarship awarded to a culinary student from Kearny High School, Paul met the recipient and her mother, who told him that the student's father had recently passed away and, without the scholarship money, she wouldn't have been able to continue her education. Years later, Paul was at Liberty National Golf Club when he was approached by the same student, who was now a chef at the prestigious club; she warmly thanked him for changing the course of her life.

Another memorable encounter took place during an HCCC Commencement ceremony at the New Jersey Performing Arts Center, when a woman from the crowd unexpectedly embraced him and said, "Mr. Silverman, without you, my son never would have graduated!" Moments like these underscore the meaningful and lasting effects of Paul's dedication.

Taking his commitment even further, Paul recently established the Silverman Family Scholarship Fund with a \$25,000 endowment to the HCCC Foundation.

Building Success, Giving Back: Jose Garcia's Commitment to HCCC

Jose "Pepe" Garcia is the founder and CEO of Maverick Building Services, one of the largest minority-owned building services firms in New Jersey, with operations spanning across New Jersey, New York City, and beyond, making it one of the most successful on the East Coast. Jose has enjoyed significant success in business, but he can still relate to today's college students who are just starting out and trying to make ends meet as they pursue their education. In fact, Jose has firsthand experience overcoming the hurdles that many of these students are navigating. Jose is a graduate of Seton Hall University, where he earned a degree in marketing. While attending Seton Hall by day, he worked full-time as a janitor cleaning an office building in Newark at night to support himself and put himself through college, so he knows a thing or two about juggling work with classes, overcoming financial challenges, and other challenges many of today's students must navigate.

It's this life experience and empathy that inspires Jose to give back to the community as a longtime supporter of the HCCC Foundation, which supports HCCC students, many of whom face significant financial challenges as they pursue their education. He is motivated to help students who have the will to succeed but lack the resources.

Jose's support of HCCC and its students is longstanding and meaningful, as is his connection to the College. Jose's mother, Hortencia Garcia, immigrated to the United States from Cuba and had to restart her education here, eventually earning her doctorate degree from Paterson State College (now William Paterson University). She worked as a teacher in the Union City School District and taught Spanish classes at HCCC as she worked three jobs to support he and his two brothers. Her resolve and determination, as well as the value she



placed on education, left a profound and lasting impression on Jose, as did the students she taught, whom he remembers as being hardworking and eager to learn but faced with many hardships. While many years have gone by since then, he finds that the same can still be said for HCCC students today, and he now feels blessed to be able to help them overcome these hurdles.

Today, Garcia is a dedicated, long-term supporter of the HCCC Foundation, honoring his mother's legacy by helping students who, like him, are striving for a better future.

What would he view as the ideal outcome of his generous support? Garcia says that "I'd love to see students achieve the American Dream and pay it forward by supporting future students. That would be my ultimate dream." he says.

For Garcia, giving isn't just about money, it's about making a real difference. Whether it's scholarships that provide students with access to education or simply knowing that he's alleviating the burden for those working their way through school, he finds fulfillment in seeing young people succeed. "It feels good when you see other people doing good," he explains.

Ultimately, Jose believes that "Through education, hard work, and being resilient and perseverant, there's nothing that cannot be obtained in one's future. There's no magic formula to success, but that's the closest thing, and I live by that."
