Financial Aid Begins with FAFSA...

HCCC school code is 012954.

File your 2024-2025 FAFSA for the Spring 2025 term only by February 15, 2025, to meet state deadline!

File your 2025-2026 for the Fall 2025 semester by April 15 to meet state deadlines.

Be sure to create your FSA ID first! Go to

https://studentaid.gov/fsa-id/create-account/launch to begin.

You will need your social security number and your own email address.

Use your 2023 federal tax return for the FAFSA application!

Go to https://studentaid.gov/ to begin.

Complete your application now and begin your journey to funding your education!

You could be eligible for a Pell grant, Federal Work Study, and state grants such as TAG or CCOG.

Eligibility requirements include:

- Be a New Jersey resident.
- Rank in the top 15% of your high school class.
- Complete a rigorous high school course of study.
- Apply for all forms of State and Federal aid.
- File the FAFSA or NJ Alternative application.
- Submit your high school transcript.

Benefits:

- Free tuition at your home county college.
- Covers up to 18 college-level credits per semester.

Glossary of Financial Aid Terms continues...

Adjusted Gross Income (AGI) – You or your family's wages, salaries, interest, dividends, etc. minus allowable deductions as reported on a federal tax return.

Financial Aid Offer or College Financing Plan – A document sent by a postsecondary institution to a student that outlines the amounts and detail of the financial aid being offered to the student, which may include scholarships, grants, loans, employment, or other forms of financial assistance to pay for college expenses.

Cost of Attendance (COA) – The amount it will cost a student to attend a post-secondary school. The cost considers those payable to the school (also referred to as direct or billable costs), but not limited to tuition, room, board, and students' fees and costs paid to others (or indirect, non-billable or discretionary) costs. The COA represents the highest dollar amount of financial aid a student can receive during an award year.

Disbursement – The transmission of award funds to the student account after certifying eligibility.

FTI – Federal tax information is data provided automatically from the IRS with your (or, in some instances, your spouse's) consent and approval for use in the FAFSA application.

Federal Pell Grant – A grant designed to assist undergraduate students in low- and moderate-income households to pay for college. The award amount is based on the cost of the institution, SAI, and enrollment status, and is subject to an aggregate limit.

Federal School Code - An identifier that the U.S. Department of Education assigns to each college or career school that participates in the federal student aid programs. In order to send your FAFSA information to a school, you must list the school's Federal School Code on your application. A list of Federal School Codes is available on the FAFSA application.
